BCAP Launches Online Hajj Financing, SIAP Haji

A wholly owned subsidiary of PT MNC Kapital Indonesia Tbk ("BCAP" or "the Company"), PT MNC Guna Usaha Indonesia ("MNGUI") is targeting new potential customers by launching SIAP Haji, an innovative web-based sharia financing which helps Muslim community in Indonesia to register and get quota for the pilgrimage.

Indonesia, as a country with the largest Muslim majority population, is one of the countries with the largest hajj quota, totaling 221,000 in 2020. However, due to the high public demand for going to the Holy Land, this quota is deemed insufficient, with some areas queuing up to 40 years. It is recorded that there are around 600 thousand new pilgrims who register every year.

The long waiting period for this hajj pilgrimage opens opportunities for MNGUI to enter retail financing and develop its sharia business unit. Through SIAP Haji, MNGUI targets to finance more than 100,000 prospective pilgrims within the next five years, excluding umrah financing.

Anak perusahaan yang dimiliki sepenuhnya oleh PT MNC Kapital Indonesia Tbk ("BCAP" atau "Perseroan"), PT MNC Guna Usaha Indonesia ("MNGUI") membidik calon konsumen baru dengan meluncurkan SIAP Haji, pembiayaan syariah berbasis web inovatif yang memberikan kemudahan bagi masyarakat Muslim di Indonesia untuk melakukan pendaftaran dan perolehan porsi haji.

Indonesia, sebagai negara dengan mayoritas penduduk muslim terbanyak, merupakan salah satu negara dengan kuota haji terbesar, sebanyak 221.000 pada tahun 2020. Namun karena tingginya permintaan masyarakat untuk ke Tanah Suci, kuota ini dirasa tidak mencukupi, dengan beberapa daerah antrian mencapai 40 tahun. Tercatat, ada sekitar 600 ribu calon jamaah haji baru yang mendaftar setiap tahunnya.

Panjangnya masa tunggu haji ini membuka peluang bagi MNGUI untuk masuk ke pembiayaan retail dan mengembangkan unit bisnis syariahnya. Lewat SIAP Haji, MNGUI menargetkan akan membiayai lebih dari 100.000 calon jamaah haji dalam waktu lima tahun kedepan, tidak termasuk pembiayaan umrah.

SIAP Haji telah mendapatkan rekomendasi Dewan Pengawas Syariah yang telah

which has been certified by the National Sharia Board and has met the sharia principles in its financing implementation.

"Hajj financing is a type of financing that has an exceptionally low inherent risk. The registration fee can be returned 100% to MNCGUI if the customer is canceled. As for the customers, this program is a short cut to get a queue number, so its beneficial for both parties," explained Paulus Cholot Janala, President Director of MNCGUI.

"MNCGUI is developing its sharia business unit to cover more segments. This financing is our first step to enter into B to C, direct to customer financing, out of our comfort zone in B to B financing." added Paulus Cholot Janala.

Apart from SIAP Hajj, MNCGUI is also preparing SIAP Umrah as a sharia financing product. The product, which is planned to be launched this second semester, has a wider target market. This is because the Muslim community makes the umrah pilgrimage as an alternative to get to the Holy Land, due to the long queues for hajj. Millions of Indonesia Muslims visited Mecca for umrah every year.

Furthermore, SIAP Haji and SIAP Umrah will become a part of SIAP, a financing apps that being developed by the Company. In addition to the two products above, SIAP will be equipped with various financing products in collaboration with

tersertifikasi oleh Dewan Syariah Nasional dan telah memenuhi prinsip syariah dalam pelaksanaan pembiayaannya.

"Pembiayaan haji merupakan tipe pembiayaan dengan inherent risk yang sangat rendah. Biaya pendaftaran dapat kembali 100% kepada MNCGUI jika nasabah batal. Sedangkan bagi nasabah, program ini merupakan short cut untuk mendapatkan nomor antrian, jadi saling menguntungkan kedua belah pihak", jelas Paulus Cholot Janala, Presiden Direktur MNCGUI.

"MNCGUI sedang mengembangkan unit bisnis syariahnya agar dapat mencakup lebih banyak segmen, pembiayaan ini merupakan langkah awal kami untuk masuk ke pembiayaan B to C, direct to customer, keluar dari zona nyaman kami di B to B financing." lanjut Paulus Cholot Janala.

Selain SIAP Haji, MNCGUI juga mempersiapkan SIAP Umrah sebagai produk pembiayaan syariah. Produk yang rencananya akan diluncurkan pada semester kedua 2021 ini memiliki sasaran pasar yang lebih luas. Hal ini dikarenakan ibadah umrah dijadikan alternatif oleh masyarakat Muslim untuk bisa ke Tanah Suci, dikarenakan antrian ibadah haji yang cukup panjang. Jutaan Muslim Indonesia mengunjungi Mekkah untuk ibadah umrah setiap tahun.

Selanjutnya, SIAP Haji dan SIAP Umrah akan menjadi bagian dari SIAP, aplikasi pembiayaan yang sedang dikembangkan oleh Perseroan. Selain kedua produk diatas, SIAP akan dilengkapi dengan berbagai produk pembiayaan hasil kolaborasi dengan MNC

MNC Finance, such as SIAP Dana Rumah, a safe home refinancing product with Freehold Certificate collateral from MNC Finance for working capital, multipurpose and investment financing; also SIAP Dana Mobil, a car refinancing product with Proof of Ownership Book as the collateral which will be a fast and easy financing solution.

All those features in SIAP apps are targeted to be launched in the second quarter of this year.


